#### **ISSUE**

Shall the Board adopt Resolution No. 2024-03 (<u>Attachment A</u>), recommending funding approval of projects for the federal 5310 grant program?

#### **BACKGROUND AND FINDINGS**

The purpose of the Section 5310 grant program is to enhance the mobility of seniors and individuals with disabilities. The Oregon Department of Transportation (ODOT) has announced the availability of the 2025-2027 biennium Section 5310 Formula funds. Salem Area Mass Transit District (District) is a designated subrecipient by ODOT to oversee the distribution of Federal 5310 funds for Marion and Polk County. The District conducted a selection process to determine the use of the funds, and to certify that projects were derived from the Coordinated Public Transit – Human Services Transportation Plan for Marion and Polk counties (Coordinated Plan) dated March 2024.

Oregon Department of Transportation (ODOT) opened the 5310 grant funding solicitation on August 22, 2024. A public notice of this year's Section 5310 grant solicitation was published in the Statesman Journal newspaper on September 18, 2024 and applications were due to the District on October 25, 2024. The amount of the grant funds available is **\$2,311,301**. Both English and Spanish versions of the notice were posted on the District's website. Announcements were sent out to current grantees of these funds to ensure they were aware of the solicitation of applications for funding. A 10.27% local match is required for this grant application. Eligible projects for this funding include vehicle purchases, passenger shelters, purchased services, preventive maintenance, travel training, marketing programs, development of centralized call centers, and equipment that supports transportation to meet the special needs of seniors and individuals with disabilities.

The STIF Advisory Committee (STIFAC) met to review 5310 grant applications for Marion and Polk County. The meeting was held on November 1, 2024 to hear presentations from applicants, discuss the projects, and make a recommendation to the Board for funding. Table 1 shows the summary of all applications received by the due date and requested grant funding for each project. In the project funding evaluation process, STIFAC prioritized to maintain current services over funding a new project or service. STIFAC recommended to fund both District and City of Woodburn's projects as requested amount and allocate the remaining \$77,519 to City of Monmouth (New PTSP).

#### FINANCIAL IMPACT

If awarded, these projects and awarded funding will be included in the FY26 and FY27 District budgets. 2025-2027 Biennium 5310 funds support projects and services from July 1, 2025 to June 30, 2027.

#### RECOMMENDATION

The STIFAC recommends that the Board adopt Resolution No. 2024-03, approving the list of projects and funding amounts of 2025-2027 federal 5310 grant funded projects and direct the General Manager to submit the Qualified Entity funding recommendation to ODOT in accordance with the STIFAC recommendation by November 20, 2024.
